Alan Zais noted that he had provided a written report to the board. Alan reported that he was working on the HUD Moving To Work (MTW) Regionalization Notice that would allow BCHA to be covered under the WCHA HUD MTW designation. Alan also said that he had contacted HUD to confirm that a subsidy layering review was not required for the addition of the four Veterans Assisted Supportive Housing (VASH) vouchers for Pearl Place, and HUD was uncertain and had deferred him to the Illinois Housing Development Authority (IHDA) for their review—HUD said they would follow the IHDA determination. Ron Wait asked about the Low Income Housing Tax Credit (LIHTC) which is the major funding source for the Pearl Place rehab, and Alan explained how LIHTC is apportioned to the states by the Internal Revenue Service, with the sale of tax credits creating equity from the private and nonprofit sectors to help fund affordable housing programs.
